ICEA 2024 Excellence Award Nomination: Demographic Targeted E-newsletters

Stakeholder communication is critical for all organizations. For Chambers of Commerce, external communication keeps stakeholders updated on our work, alerts them to potential impacts on their business, and educates them about valuable resources. Relevant external communication helps justify their investment in the chamber.

Chamber membership is comprised of every type of business imaginable, from solopreneurs to large corporations, and represents hundreds of industries. Members invest for different reasons, meaning they need different content from us. Adding additional stakeholders to our recipient list, such as elected and appointed officials who need other unique content, made it even more difficult to produce concise, quality pieces.

Challenge: Aspire produced a weekly e-newsletter since our formation. As we grew both membership and initiatives, it became difficult to communicate to a diverse audience in one weekly e-newsletter. It also became difficult to effectively brand ourselves to key stakeholders as the local source for economic development data and trends, a reliable resource for small business news, and a connection to local government activity.

We needed to develop new communications that would allow us to segment news to targeted groups of stakeholders without overdelivering – "loading up the inbox."

Solution - New E-newsletters: Aspire identified three groups of stakeholders that needed different information – (1) general stakeholders, (2) top investors, and (3) government officials. General stakeholders still receive our weekly e-newsletter. For the latter two groups, we developed new monthly communications in 2023.

- Aspire Report for Top Investors (ARTI) A video report from our Vice President of Investor Development and Relations emailed monthly to executives at organizations that invest at our highest tiers. The content is updates on our work, primarily in advocacy, workforce development, and member services. It also includes links to resources related to the content.
- Economic Report for Government Officials (ERGO) A report from our Vice President of Economic Development emailed monthly via Constant Contact to local elected and appointed officials. Content includes a (1) brief article on an economic development topic, (2) local government official profile, (3) an economic snapshot dashboard, and (4) fun local trivia. It is designed to be a quick read with few or no links to click.



Outcomes: ARTI was originally distributed to 110 members and ERGO to over 90 government officials. Distribution lists continue to increase as recipients have forwarded the e-newsletters to others who then subscribed (ARTI is up 19% and ERGO is up 10%).

ARTI has an average open rate of 34.7%, up 10% from its launch. ERGO's average open rate is 37.8%, holding steady since its launch but we believe this is remarkable because initial recipients did not opt-in; we curated a list of those we wanted to receive it and sent it to them unannounced!

Unexpectedly, since releasing these targeted e-newsletters, we then saw the open rate for our general weekly e-newsletter increase by nearly 5%. This reinforces our belief that targeted messaging would help with overall stakeholder engagement.

Aspire Johnson County will continue to publish ARTI and ERGO monthly and evaluate additional opportunities for targeted communications to other groups of stakeholders.


